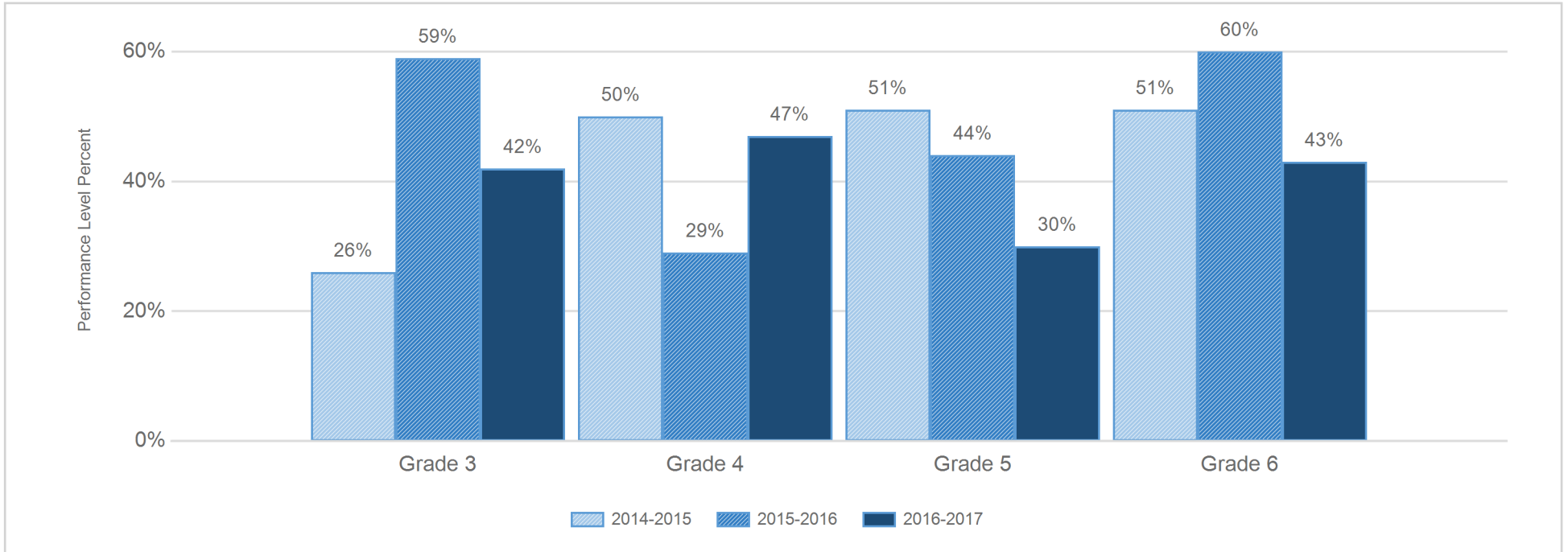

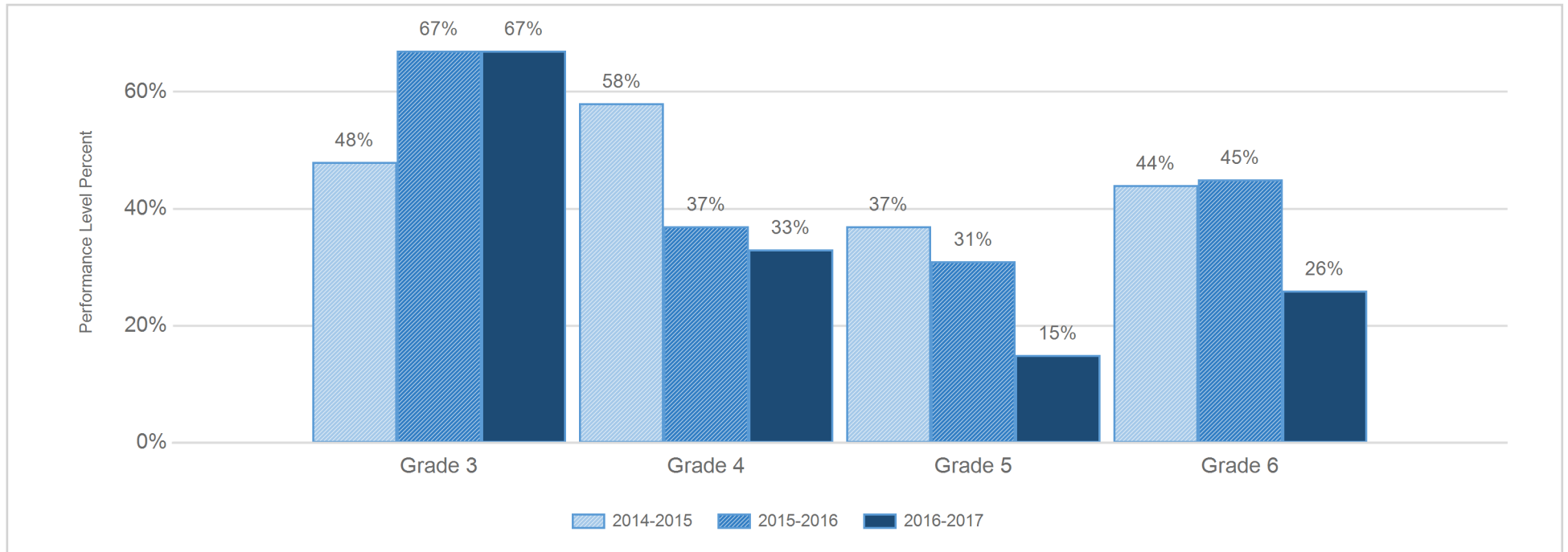

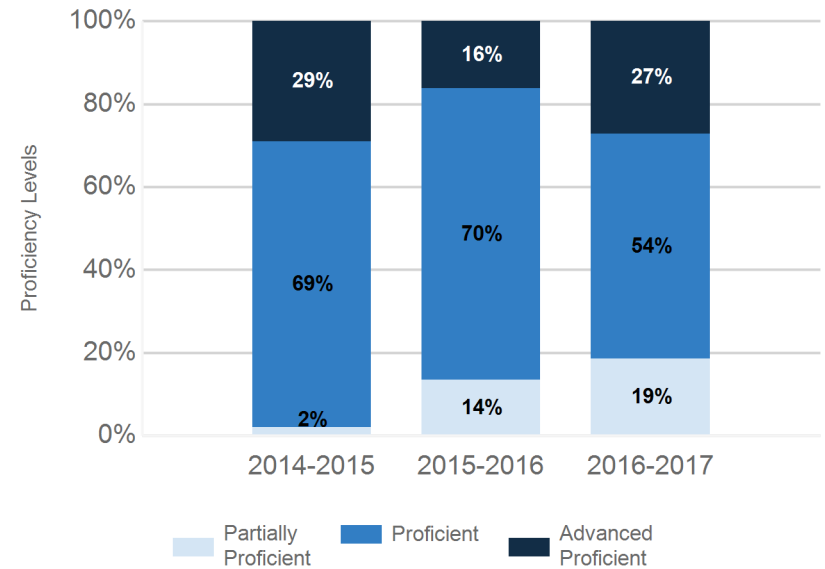

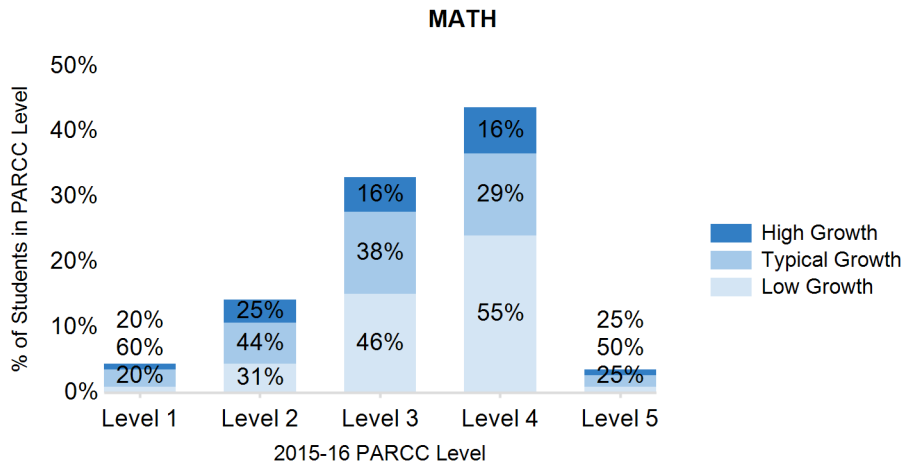
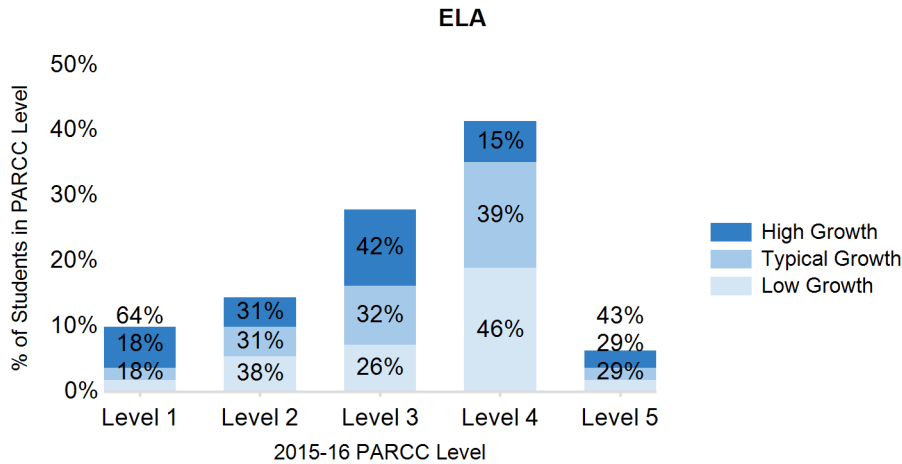

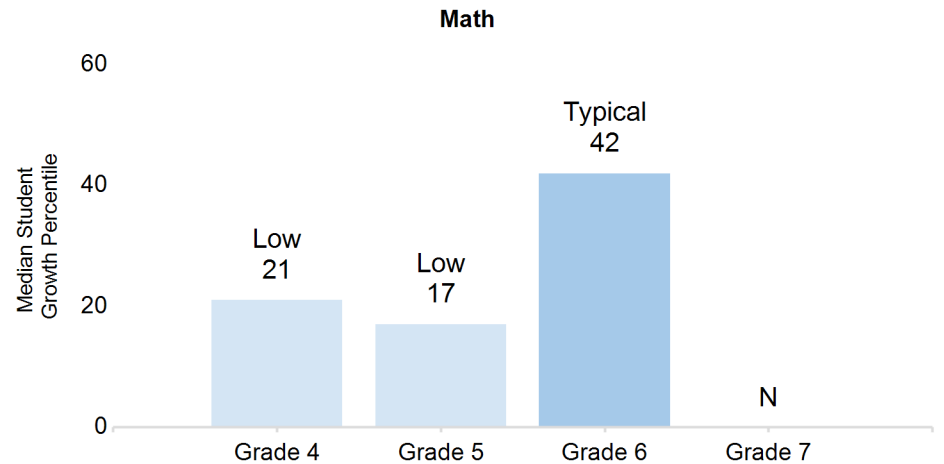
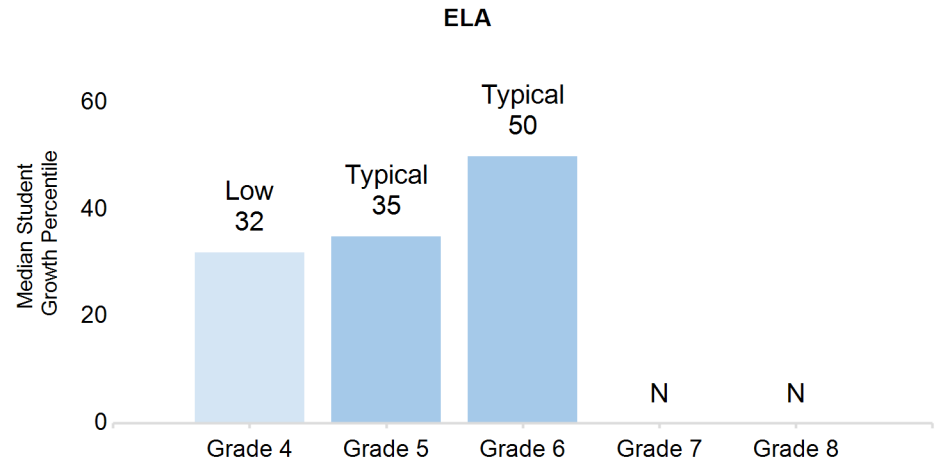

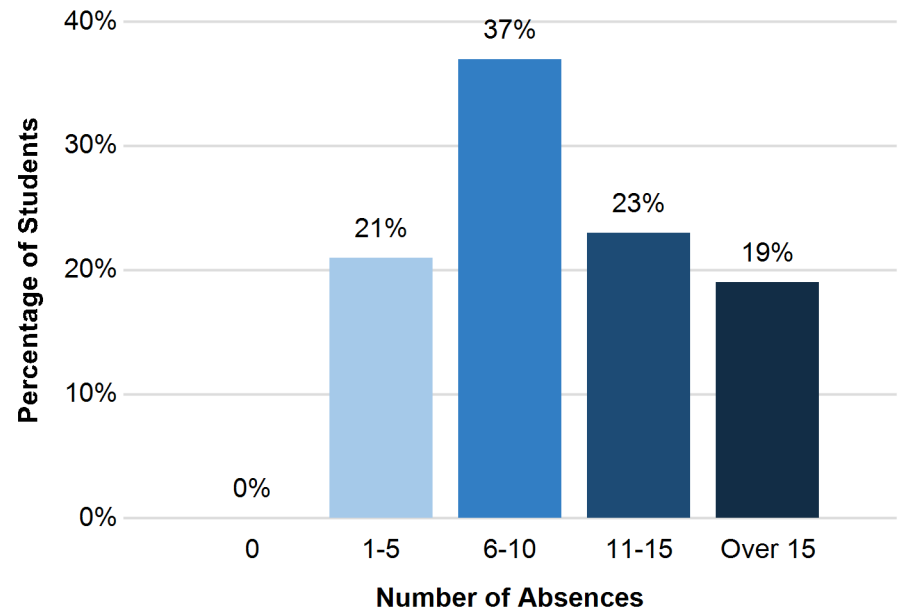

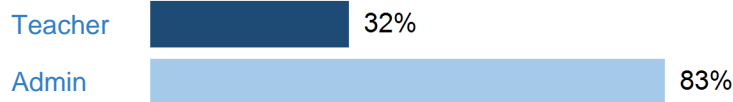

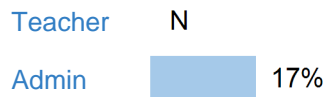

Other Information:

The Parkview Elementary School will continue to enhance student achievement through the implementation of best educational practices. During the 2017-2018 school year, the staff, students and families of Westville will continue to focus on Language Arts Literacy, Mathematics, Technology and Career Ready Practices. Currently, our teaching staff continues to utilize multiple resources to address the New Jersey Student Learning Standards. English Language Arts incorporates a balanced approach to literacy through guided reading, independent reading, shared reading and writing workshop. Our Math curriculum addresses the New Jersey Student Learning Standards through the use of envision Math and the Center for Teaching and Learning. Teachers, in conjunction with the curriculum department, have developed yearly local assessments to enable our staff to monitor student progress. Our students have demonstrated significant gains in open ended analysis and critical thinking skills. Technology continues to flourish. Presently, our students in third through sixth grades have a 1:1 Chrome Book ratio. Students in pre-kindergarten through second grade utilize mobile computer carts equip with lap top computers, chrome books and ipads. Smart boards are currently in every first through sixth grade classroom. Students and staff integrate technology throughout the curriculum.
